Representations, Warranties, and Covenants

- intended to be relied upon
- Warranty assurance of a fact coupled with an implicit indemnification obligation if false
- Covenant ongoing promise to act or refrain from acting, to maintain a certain factual condition

Reps and Warranties

- Little distinction in practice (because a contract usually specifies remedies in case reps and warranties are false)
- Snapshot in time
- Used to smoke out facts
 - Cf. depositions
- Used to allocate risks

Kinds of representations

- About the contract "enforcability representations"
- Subject-matter representations
- Representations about the parties

Represtentations: Exceptions

- "except for those disposed of in the normal course of business ..."
- "except for those set forth on Schedule G"

Bring downs

- Schedule F describes all of FunCo's funnel cake stands as of the Closing Date.
- All of FunCo's funnel cake stands are described in Schedule F or have been introduced in accordance with Section 28-6.
- All funnel cake stands are described in Schedule F, which may be updated from time to time with the consent of Hexetron, such consent not to be unreasonably withheld.

Survival of representations

- Representations may "survive the closing"
- Representations may merge or terminate at closing
 - As is / where is

Covenants

- Affirmative
- Negative (or "restrictive")
- Financial

Covenants: Exceptions

Carveouts

- The Operator shall not make repairs or modifications to the vessel, except for those that are required for safe operation.

Baskets

- The Operator shall not make any repairs or modifications to the vessel, except for ordinary maintenance costing in aggregate no more than \$10,000.

Specification of Remedies

- Specify remedies if covenants are breached or representations are false
 - Specific performance
 - Liquidated damages
 - Time to cure
 - Penalties

Specification of Remedies

- Specify remedies if covenants are breached or representations are false
 - Specific performance
 - Liquidated damages
 - Time to cure
 - Penalties

Conditions Precedent

- Conditions that must be satisfied before performance is required
- Timing issues: delayed closing
- "Outs"

Common conditions precedent

- Breach of covenants or reps
- Bringdown of representations
- Delivery of certified documents
- Evidence of corporate action
- Incumbency certificate
- Government approvals
- Third-party consents
- Legal opinions
